Permits ARE Required

Driveway and General Building Permits are required in the Town of Tilden and are issued by the Town Clerk. A Plot Plan must be provided along with the application (found on the website) to the Town of Tilden. There is no zoning in the Town of Tilden, however, the Town does have ordinances that affect land use. Building permits take time to issue, allow 7 to 10 days before your project begins.

New home construction requires filling out an online Wisconsin Uniform Dwelling Permit Application and contacting Chippewa County Planning and Zoning office.

Burn Permits

Burn permits are not required for burn barrels, campfires, or cookouts. But are required for ALL other fires. There is NO burning on SUNDAYS OR HOLIDAYS. Please be responsible! **You may NOT leave a message saying you are going to burn.** You must call one of the people listed below to obtain a burning permit number.

Dog License

The owner of any dog(s) FIVE months of age or older shall annually obtain a license from the Town of Tilden Treasurer's office pursuant to Wisconsin State Statute 174.051(1)

The licensing year is January 1st – December 31st.
