

Chapter 3
Establishing the Boundaries of Tilden's Voting Wards
 (Ordinance Amendment 10/13/2021 sbp)

State of Wisconsin

SECTION 1 – Title and Purpose

The title of this ordinance is Establishing the Boundaries of Town of Tilden's Voting Wards. The purpose of this ordinance is to organize the Town of Tilden into three (3) voting wards in a good faith effort to work with Chippewa County's Supervisory Districting plan based on the current decennial census.

SECTION II – Authority

The Town Board of the Town of Tilden, Chippewa County, Wisconsin, has the specific authority under s. 5.15, Wis. stats., to adopt this ordinance.

SECTION III – Adoption of Ordinance

This ordinance, adopted by a majority of the town board on a roll call vote with a quorum present and voting and proper notice having been given, establishes the boundaries of Tilden's three (3) voting wards. The voting ward boundaries are as follows:

Ward #	Description of Ward	Population	Polling Place
1	East of State Hwy 53 & North of a line starting at the intersection of County Hwy. S and State Hwy 53, East on County Hwy S to the intersection of County Hwy Q, then continuing East along Tilden's Southern border to Tilden's Eastern and Northern borders.	629	Tilden Town Hall 10790 100 th Ave. Chippewa Falls, WI
2	West of State Hwy 53 & North of a line starting at the intersection of County Hwy. S and State Hwy 53 to Tilden's Western and Northern borders	570	Tilden Town Hall 10790 100 th Ave. Chippewa Falls, WI
3	South of a line starting at the intersection of County Hwy. S and Tilden's Western border, East on County Hwy S to the intersection of County Hwy Q, bounded by Tilden's Eastern, Southern and Western borders.	317	Tilden Town Hall 10790 100 th Ave. Chippewa Falls, WI
